

Post Adoption Communication Services



POST-ADOPTION COMMUNICATION

Christian Family Adoptions (CFA) has been keeping birthparents and adoptive families in touch since 2002. We are one of the only private agencies in Oregon that provides post-adoption communication with not only our own clients, but also through the state for qualified adoptive families.

Our services are offered until the adopted child turned 18 years of age, or until contact ceases or is terminated. It will be important that families continue to provide updated information (changes to address, last names, phone numbers) to CFA over the years.

Families interested in using our post-adoption communications services will need to submit this application and provide CFA with a copy of their contact or open adoption agreement between the adoptive and birth families. CFA is not responsible for enforcing contact agreements.

SERVICES

Sending letters, photos, packages, or setting up visits through CFA is a healthy way for the adoptive and birth families and the child to have a relationship, while maintaining some privacy of contact info. Our mediation services ensure that only an agreed upon level of identifying information can be shared between parties. Consider below what services you may be interested in:

Routed Correspondence:

Correspondence is reviewed by CFA staff, and communication that follows the contact agreement is forwarded. Confidential copies are kept in the file for documentation. All identifying information (last names, addresses, phone numbers) will be redacted unless otherwise instructed.

Gifts:

Will be forwarded through mail or direct pick-up if the family resides in the local area. The contact agreement should specify if there are arrangements for gifts to be exchanged.

Visitation:

We can assist families in setting up independent or supervised visits, advisably in a public space.
